Warnings Relating to Coronavirus/COVID-19 for
Onsite Volunteer Service

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and has significant person-to-person spread. As a result, federal, state, and local governments and federal and state health agencies have recommended social distancing measures and have, in many locations, required ongoing prohibitions on the congregation of groups of people of various sizes.

While COVID-19 can cause mild symptoms in some individuals, it can lead to severe illness and even death in others. **Adults over age 65** and **people of any age with serious underlying medical conditions** including, but not limited to, **HIV, asthma and other respiratory conditions**, and **pregnancy**, may be a **higher risk for more serious complications from COVID-19**.

The North Penn Valley Boys & Girls Club has made the decision to reopen now that community transmission rates have declined and has put in place preventative measures to reduce the spread of COVID-19, guided by the CDC and local health agencies. These include, but are not limited to social distancing, reduced staff to member ratios, wellness monitoring, increased sterilization, required hand-washing, and mandated masks for anyone on Club premises. These measures have been put in place to reduce the spread of COVID-19; however, the Club **cannot guarantee** that you will not become infected with COVID-19. Further, volunteering onsite at the Club **could increase** your risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by volunteering onsite at the Club and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the Club may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club management, employees, volunteers, and program participants and their families.
