THREE SCHOOL DISTRICTS-NORTH PENN, SOUDERTON, AND WISSAHICKON-PARTNER WITH US ON PROJECT LEARN. THE DISTRICTS IDENTIFY, SELECT, AND TRANSPORT STUDENTS TO US DAILY AS WELL AS SHARE CRITICAL INFORMATION TO HELP US ASSIST EACH STUDENT THAT INCLUDES REPORT CARD GRADES AND READING BENCHMARK SCORES. PROJECT LEARN HAS BEEN AWARDED THE PENNSYLVANIA STATEWIDE YOUTH DEVELOPMENT AWARD. ALL STUDENTS WILL BE LOW-INCOME AND RECEIVED FREE OR REDUCED-COST LUNCH. DURING THE PANDEMIC, ACADEMIC HELP AND KEEPING CHILDREN HEALTHY WERE THE FOCUS OF OUR PROGRAM.
